1. INTRODUCTION TO THE UNIVERSITY

The Maharishi Mahesh Yogi Vedic Vishwavidyalaya (MMYVV) was established by the Act No. 37 of 1995 of Madhya Pradesh Government vide gazette notification no 573 dated 29 November 1995. The University head office is at - Brahmasthan of India, Karaundi, District-Katni, Madhya Pradesh. The University is reputed to disseminate quality education. The University is an affiliating university with Jurisdiction spread over entire Madhya Pradesh. His Holiness Maharishi Mahesh Yogi Ji was the first Chancellor of the University. Presently Brahmachari Girish (Dr. Girish Chandra Varma) is the Chancellor.

MMYVV has been recognized and included in the list of Universities, maintained by the UGC under section 2 (f) of the UGC Act, 1956. It is also a member of Association of Indian Universities. The University offers Ph.D., Post Graduate Degree/Diploma, Graduate and Diploma/Certificate Programmes in Vedic Science, Education, Management and Computer Science. D.Ed., B.Ed. and B.P.Ed. courses are approved by National Council of Teachers Education [NCTE].

University has established its Directorate of Distance Education in Vijay Nagar, Jabalpur and is initially operating through its 8 centers across M.P. The Directorate of Distance Education has introduced B.A., B.Com., BCA, CIC and Post Graduate Diploma in Audio Programme Production (PGDAPP). These courses are approved by the Distance Education Council (DEC). MMYVV, is a IGNOU Partner Institution for Scheme of Convergence of Open & Distance Learning (ODL) & Conventional systems. Under this scheme 24 selected programmes are offered to the students at Bhopal, Indore and Jabalpur campuses of MMYVV in MP. MMYVV students can now qualify for dual degrees in the same

academic year by combining one regular and one convergence course concurrently. To further assist students audio-visual rooms are being setup in select campuses so that students can listen to educational programmes broadcast through Satellite and Internet as also exploit multi-media for learning.

2. SPECIAL FEATURES OF EDUCATION AT MMYVV

Maharishi's Vedic Science - Consciousness Based Education

Students at Maharishi Mahesh Yogi Vedic Vishwavidyalaya are given an integrated, unified version of all aspects of life through study of the principles of Maharishi's Vedic Science and Technology and study of the Laws of Nature, which structure and uphold growth and progress in all forms of nature, including human life. 3. GENERAL INFORMATION AND RULES FOR STUDENTS

3.1 Offices, Campus and Departments

As per the provisions of Act, the Head Office of the University is at Brahmsthan, Karaundi, District Katni, Madhya Pradesh.

Administrative Office of the University is at Lamti, Vijay Nagar, Jabalpur, M.P.

Directorate of Distance Education and Department of Education are located at Vijay Nagar, Jabalpur. MMYVV has three sprawling Vastu built, peaceful, pollution free, serene campuses at State capital Bhopal, business city Indore and cultural city Jabalpur, famous for its marble rocks, on the bank of Holy Narmada River.

Jabalpur campus is 150 acres newly constructed, situated on the Eastern bank of pious river Narmada. The campus has residential facilities for 400 students consisting of administrative and academic blocks, hostel blocks, dining halls, modern kitchens, 30,000 sq ft. auditorium, meditation halls, library, computer labs, faculty residence, indoor and out door sports facilities. Total constructed area of the campus is about 300,000 sq ft. Jabalpur City Campus of MMYVV is at Lamti, Vijay Nagar.

MMYVV campus at Bhopal, the city of lakes and one of the greatest King of India-Raja Bhoj is built in 50 acres, situated at Berasia Road, a state highway, only 15 minutes drive from Bhopal Airport, Bus Stand and Railway station. The campus has residential campus with facilities for more than 1000 students consisting of administrative and academic blocks, separate hostel blocks for boys and girls to accommodate up to 500 students, dining halls, modern kitchens, meditation halls, library, computer labs, faculty residence, indoor and out door sports facilities. Bhopal campus is has a unique facility to cater for students from Nursery to Ph.D. level as a full fledged CBSE school and a Management Institute are co-located in the same campus. Equestrian training facilities and state of the art audio-visual studio is another attraction of the campus. Total constructed area of the campus is about 400,000 sq ft.

Indore, city known to be financial capital of Madhya Pradesh and Educational Hub has its present MMYVV campus in 08 acres land situated at Rau, Cat Road, on the way to famous Military Cantonment-Mhow.

The campus has facilities for 150 hostlers, has administrative and academic block, dining hall, modern kitchen, meditation halls, library, computer lab, indoor and out door sports facilities. Total constructed area of the campus is about 150,000 sq ft.

3.2 Academic Programmes

The University offers programmes (see programme chart on page 7 onwards) in English/Hindi medium only, leading to certificate, diploma, graduate and post graduate degree/diploma covering conventional, Distance as well as innovative programmes. Most of these programmes, developed and launched by the University are professional and provide greater job opportunities to the students in the job market and simultaneously provide life oriented, life-supporting knowledge.

MMYVV campuses have flexible timings for instructions, studies and contact programmes during weekends under ODL for employees of corporate, industry, Defence personnel's, working women and house wives.

The University uses multimedia & other technological advancements for imparting instructions to the students comprising of the following:

- * Use of audio-video programmes.
- * Effective face-to-face interaction with faculty.
- * Project work.
- * Work related field projects.
- * Interaction with international faculty and experts through telecast and video lectures.
- * Local Industry visits and Guest Speakers from Corporate and Industries.

3.3 Admission

The students fulfilling the eligibility conditions and on payment of prescribed programme fee laid down for regular courses of the University and other courses of IGNOU under convergence scheme shall be admitted in respective courses and campuses.

Students desirous of seeking admission for any of the listed courses may contact either in one of the university campuses (Bhopal, Indore and Jabalpur) or in its Administrative office at Lamti, Vijay Nagar, Jabalpur.

3.4 Identity Card

The admitted student will be issued an Identity Card as a bonafide student of the University. Student has to produce the Identity Card to prove his identity, whenever required. Loss of the Identity Card should be immediately reported to the Campus Head. Duplicate Identity Card will be issued on payment of Rs. 50.00.

3.5 Course Material

For regular MMYVV courses University only recommends names of books for study by the students. The student may procure these under his own arrangements. Students admitted in convergence scheme will receive IGNOU study material. The cost of study material for IGNOU courses is included in fee structure.

The level of the interaction with the faculty shall depend on the choice of courses; MMYVV courses or IGNOU courses. In case of MMYVV courses, there will be full time classes. For IGNOU courses contact classes will be conducted as per IGNOU guidelines for different courses.

3.6 Student Support Services

All university campuses have Student Support Service Office. For any question or enquiry regarding courses, classes, teaching schedule etc. students may please contact this office of the university.

3.7 Fee

All the student seeking admission in the programmes offered by the MMYVV are required to submit a Demand Draft of prescribed fee for the

first semester (in case of semester wise courses) or for complete year (in case of non-semester courses) to be drawn in favour of MMYVV payable at Jabalpur along with the filled in Application form.

Note :

1. All fees are payable through Demand Draft in favour of MMYVV payable at Jabalpur. No cash should be handed over to any one for any reason.
2. Late fee after notified closing date-
(a) First 15 days- Rs. 200/- (b) Next 15 days- Rs. 500/-
3. Each Semester is of 6 month's duration and the fee for all semester based courses is payable on Semester basis.
4. In case of non-semester courses, the fee for complete one year is payable at the time of admission.
5. Information brochure & Application Form can be obtained on payment of Rs. 250.
6. Examination fee per paper is payable at the time of submission of examination form. Please see fee chart for details.

3.8 Refund of Fee

Fee for all the ineligible candidates will only be refunded after deduction of admission charges. Fee paid in all other cases will not be refunded under any circumstances, However in cases where University denies admission the fee will be refunded in full.

3.9 Change of Electives/ Programme

Change in Elective / Programme is permitted only within the first 30 days of commencement of the regular programme on payment of Rs 200/-. Students undergoing Convergence courses may similarly apply within 30 days failing which they will be subject to applicable rules of IGNOU.

3.10 Validity of admission:

Students offered admission have to join on or before the due dates specified by the University. In case students seek admission for the next session, they have to apply afresh and go through the admission process again. For courses under IGNOU's convergence scheme admission will be

open throughout the year except for the programmes where entrance exam is held by IGNOU.

3.11 Incomplete and Late Applications

Incomplete application forms and application forms received after notified last date (including the period prescribed with late fee) will be summarily rejected without any information to the students. The students are, therefore required to fill the application form carefully and enclose the attested copies of all the relevant certificates.

3.12 Simultaneous Registration - Dual Programme

Subject to eligibility criteria of programme applied, a student may under take two Post Graduate programmes/Graduate programmes/Post Graduate Diploma programmes concurrently in same academic year with the proviso that at least one programme will be under taken in ODL mode. In case of Diploma/Certificate Programmes, the student is permitted to complete two diploma or two certificate courses concurrently under ODL

Students who are already enrolled in a programme of one year or longer duration can also simultaneously register themselves for any Post Graduate Diploma/Diploma/Certificate Programme of one year duration. However, if there is any clash of dates of Counseling or examination schedule of the two programmes taken, University would not be in a position to make adjustment.

3.13 Disputes on admission & Other University Matters

In case of any dispute arising on account of any reasons, the decision of Vice-Chancellor MMYVV will be final. The place of jurisdiction of filing of suit, if necessary, will be only Jabalpur [MP].

3.14 Recognition

Maharishi Mahesh Yogi Vedic Vishwavidyalaya is established by the legislature of State of Madhya Pradesh. All Degree/Diplomas/Certificate courses offered by Maharishi Mahesh Yogi Vedic Vishwavidyalaya are at par with Degree/Diplomas and Certificate of other universities in India, established under statutory provisions of central or state governments. MMYVV has been recognized and included in the list of Universities, maintained by

the UGC under section 2 (f) of the UGC Act, 1956. It is also a member of Association of Indian Universities.

3.15 Dress And Discipline

Male and female students are encouraged to exhibit high sense of personal hygiene, sober dress sense, cultivate good manners and display well honed social graces. Use of vulgar language or unruly conduct or attempt at eve teasing will invite penal action from university authorities. Use of Mobiles inside campus **buildings** or chewing of paan, tobacco or other intoxicants including drinks is strictly prohibited on campus. Wearing of ill fitting clothes or tight jeans, top, polo, T-shirts, half trouser etc. reflects poor upbringing. Students are encouraged to wear traditional dignified Indian dresses of pastel shades or other light colours Viz for gents Kurta/Shirt and Pajama/Dhoti/simple Trouser or Salwar and Kurta/Kameez Suit/Sari

3.16 RAGGING

As per directions of the Honourable Supreme Court of India ragging is prohibited. If any incident of ragging comes to the notice of the authorities the concerned student shall be given liberty to explain and if his/her explanation is not found satisfactory the authority would expel him/her from the university. Guidelines of Honourable Supreme Court, UGC, and Ministry of Higher Education of Madhya Pradesh Government will be followed by MMYVV strictly.

Note: The MMYVV reserves the right to change, at any time, without prior notice, programmes of study, course offering, academic requirement, the academic calendar, codes of conduct, tuition, room and board changes, and other fees, policies, and procedures. The MMYVV will determine the times at which all such changes are effective. Changes may apply not only to prospective students but also to those who are already enrolled in the University. MMYVV also reserve the right to admit. The Brochure is published for informational purpose and should not be construed as the basis of a contract between a student and MMYVV. Every effort is the made to provide information that is accurate at the time the brochure is prepared.
